

# REPUBLIC OF THE PHILIPPINES INTER-AGENCY TASK FORCE FOR THE MANAGEMENT OF EMERGING INFECTIOUS DISEASES

### **RESOLUTION NO. 72**

Series of 2020 September 17, 2020

WHEREAS, on March 16, 2020, to prevent the sharp rise of COVID-19 cases in the country, the President placed the entirety of Luzon under Enhanced Community Quarantine until April 14, 2020;

WHEREAS, on April 30, 2020, the Office of the Executive Secretary issued Executive Order (E.O.) No. 112 Imposing an Enhanced Community Quarantine in High-Risk Geographic Areas of the Philippines and a General Community Quarantine in the Rest of The Country from 01 To 15 May 2020, Adopting The Omnibus Guidelines On The Implementation Thereof, And For Other Purposes;

WHEREAS, on August 27, 2020, the IATF adopted major changes in the COVID-19 risk-classification method for Provinces, Highly Urbanized Cities, and Independent Component Cities, use of new parameters for escalation and de-escalation of community quarantine classification, revised procedure for reporting and recommendations for risk classifications, and standardization of requirements for provinces, HUCs, and ICCs applying for de-escalation from GCQ to MGCQ;

**WHEREAS,** as of September 16, 2020, there are total of Sixty Thousand Three Hundred Forty-Four (60,344) active COVID-19 cases in the Philippines;

**NOW, THEREFORE, BE IT RESOLVED,** as it is hereby resolved, that the IATF approves the following:

A. The recommendations of the Department of Health Technical Advisory Group, in coordination with the Department of Tourism (DOT) and the Department of the Interior and Local Government (DILG), and with the assistance of the World Health Organization (WHO), to commence pilot studies on the use of Rapid Antigen Tests (Ag-RDTs) for border screening and serial testing in high-risk to low-risk interzonal travel considering cross-border differences in quarantine status and the prevalence level of transmission, as well as for specialized programs of the Department of Tourism, are hereby approved.

- B. The decision of the IATF Technical Working Group is hereby ratified. Notwithstanding the provisions of the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines, as amended, these rules shall govern all activities relating to the observance of *Undas* season in all private and public cemeteries, and memorial parks, including columbariums and the like, effective upon approval of this Resolution and until November 15, 2020:
  - 1. The number of visitors shall be limited to a maximum of thirty percent (30%) of the venue capacity, with the wearing of face masks and face shields, and the observance of social distancing;
  - 2. All private and public cemeteries, and memorial parks, including columbariums and the like throughout the country shall be closed to visitors from October 29 to November 4, 2020. *Provided, that,* the Omnibus Guidelines on the Implementation of Community Quarantine shall continue to govern burial and cremation activities during the said period; and
  - 3. Age restrictions shall not apply to visitors of the aforementioned places.

**RESOLVED FURTHER**, the Chairperson and/or the Co-Chairperson shall be duly authorized to sign for and on behalf of the Inter-Agency Task Force.
