Glossary of Acronyms, Terms, and Abbreviations

ABC – Approved Budget for the Contract.

BAC – Bids and Awards Committee.

Bid – A signed offer or proposal to undertake a contract submitted by a bidder in response to and in consonance with the requirements of the bidding documents. Also referred to as *Proposal* and *Tender*. (2016 revised IRR, Section 5[c])

Bidder – Refers to a contractor, manufacturer, supplier, distributor and/or consultant who submits a bid in response to the requirements of the Bidding Documents. (2016 revised IRR, Section 5[d])

Bidding Documents – The documents issued by the Procuring Entity as the bases for bids, furnishing all information necessary for a prospective bidder to prepare a bid for the Goods, Infrastructure Projects, and/or Consulting Services required by the Procuring Entity. (2016 revised IRR, Section 5[e])

BIR – Bureau of Internal Revenue.

BSP – Bangko Sentral ng Pilipinas.

Consulting Services – Refer to services for Infrastructure Projects and other types of projects or activities of the GOP requiring adequate external technical and professional expertise that are beyond the capability and/or capacity of the GOP to undertake such as, but not limited to: (i) advisory and review services; (ii) pre-investment or feasibility studies; (iii) design; (iv) construction supervision; (v) management and related services; and (vi) other technical services or special studies. (2016 revised IRR, Section 5[i])

CDA - Cooperative Development Authority.

Contract – Refers to the agreement entered into between the Procuring Entity and the Supplier or Manufacturer or Distributor or Service Provider for procurement of Goods and Services; Contractor for Procurement of Infrastructure Projects; or Consultant or Consulting Firm for Procurement of Consulting Services; as the case may be, as recorded in the Contract Form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.

CIF – Cost Insurance and Freight.

CIP – Carriage and Insurance Paid.

CPI – Consumer Price Index.

DDP – Refers to the quoted price of the Goods, which means “delivered duty paid.”

DTI – Department of Trade and Industry.

EXW – Ex works.

FCA – “Free Carrier” shipping point.

FOB – “Free on Board” shipping point.

Foreign-funded Procurement or Foreign-Assisted Project– Refers to procurement whose funding source is from a foreign government, foreign or international financing institution as specified in the Treaty or International or Executive Agreement. (2016 revised IRR, Section 5[b]).

Framework Agreement – Refers to a written agreement between a procuring entity and a supplier or service provider that identifies the terms and conditions, under which specific purchases, otherwise known as “Call-Offs,” are made for the duration of the agreement. It is in the nature of an option contract between the procuring entity and the bidder(s) granting the procuring entity the option to either place an order for any of the goods or services identified in the Framework Agreement List or not buy at all, within a minimum period of one (1) year to a maximum period of three (3) years. (GPPB Resolution No. 27-2019)

GFI – Government Financial Institution.

GOCC – Government-owned and/or –controlled corporation.

Goods – Refer to all items, supplies, materials and general support services, except Consulting Services and Infrastructure Projects, which may be needed in the transaction of public businesses or in the pursuit of any government undertaking, project or activity, whether in the nature of equipment, furniture, stationery, materials for construction, or personal property of any kind, including non-personal or contractual services such as the repair and maintenance of equipment and furniture, as well as trucking, hauling, janitorial, security, and related or analogous services, as well as procurement of materials and supplies provided by the Procuring Entity for such services. The term “related” or “analogous services” shall include, but is not limited to, lease or purchase of office space, media advertisements, health maintenance services, and other services essential to the operation of the Procuring Entity. (2016 revised IRR, Section 5[r])

GOP – Government of the Philippines.

GPPB – Government Procurement Policy Board.

INCOTERMS – International Commercial Terms.

Infrastructure Projects – Include the construction, improvement, rehabilitation, demolition, repair, restoration or maintenance of roads and bridges, railways, airports,

seaports, communication facilities, civil works components of information technology projects, irrigation, flood control and drainage, water supply, sanitation, sewerage and solid waste management systems, shore protection, energy/power and electrification facilities, national buildings, school buildings, hospital buildings, and other related construction projects of the government. Also referred to as *civil works or works*. (2016 revised IRR, Section 5[u])

LGUs – Local Government Units.

NFCC – Net Financial Contracting Capacity.

NGA – National Government Agency.

PhilGEPS - Philippine Government Electronic Procurement System.

Procurement Project – refers to a specific or identified procurement covering goods, infrastructure project or consulting services. A Procurement Project shall be described, detailed, and scheduled in the Project Procurement Management Plan prepared by the agency which shall be consolidated in the procuring entity's Annual Procurement Plan. (GPPB Circular No. 06-2019 dated 17 July 2019)

PSA – Philippine Statistics Authority.

SEC – Securities and Exchange Commission.

SLCC – Single Largest Completed Contract.

Supplier – refers to a citizen, or any corporate body or commercial company duly organized and registered under the laws where it is established, habitually established in business and engaged in the manufacture or sale of the merchandise or performance of the general services covered by his bid. Section I. Invitation to Bid

1. The Presidential Communications Office (PCO), through the General Appropriations Act of 2023 intends to apply the sum of **Eighteen Million Eight Hundred Seventy-Eight Thousand Seven Hundred Sixty Pesos (PHP 18,878,760.00)** being the ABC to payments under the contract for the project: **Supply, Delivery, and Testing of Mirrorless and Full-frame Cameras with Complete Accessories for the Visayas Media Hub Project (Procurement/Contract No. 2023-PCO-074).**

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The PCO now invites bids for the above procurement project. Supply and Delivery of the Goods shall be in accordance with Section VI. Schedule of Requirements, and Section VII. Bidders should have completed, within **five [5] years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from PCO BAC Secretariat and through the e-mail address given below and inspect the Bidding Documents posted at the PCO website.

5. A complete set of Bidding Documents, in digital copy, may be acquired by interested Bidders starting **30 September 2023** from the PCO website given below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos (PHP 10,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees by sending a clear scanned copy of the Official Receipt **on or before the deadline of submission of bids** to the PCO BAC Secretariat e-mail given below.
6. The PCO will hold a Pre-Bid Conference on **10 October 2023** at **11:00 AM** at the 7th Floor Diplomatic Lounge, Times Plaza Building, UN Avenue, Ermita, Manila City. A pre-registration shall be required for all interested suppliers to participate further in the procurement activities as scheduled. Those interested bidders must provide complete information in the Google Forms which may be accessed via this link: <https://forms.gle/gK8SYhuZKUiJ2SvL6>.

Maximum of Two (2) authorized representatives will be allowed to join the Pre-bid conference per company.

Prospective bidders are encouraged to discuss any concerns or clarifications about the eligibility requirements including the technical specifications in the said conference.

7. Bids must be duly received and acknowledged by the BAC Secretariat through manual submission at the office address indicated below **on or before 26 October 2023 at 8:00AM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **26 October 2023** at **1:30PM** at 7th Floor, PCO Diplomatic Lounge, 7th Floor, Times Plaza Building, UN Avenue, Ermita, Manila.
10. Prospective bidders are requested to organize and submit their Bids manually and suppliers are hereby reminded, as follows:
 - a) Bidders shall drop their duly accomplished eligibility requirements, technical and financial proposals in two separate sealed envelopes in the designated bid box located at the
 - b) To facilitate the evaluation of documents, the bidder is encouraged to include a table of contents per envelope, corresponding page numbers, and title pages before the actual document. 11. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity. Late bids shall not be accepted.
12. The PCO reserves the right to reject all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in according to Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.

TERMS OF REFERENCE

Project details:	<p>The Visayas Media Hub (VMH) will house the Communications arm of the government in the Central Philippines and will cater to tailor-fitted news and information for its regions.</p> <p>The project will complete the triumvirate of the Main Government Broadcast hubs in Luzon, Visayas, and Mindanao.</p> <p>Having a centralized and integrated facility for government media entities will ensure close coordination among themselves which in turn will result in reaching wider and more effective information dissemination for the Visayas region. With its modern high-definition equipment, the VMH will serve as the central broadcast source of the government serving different regions in the Visayas. It will also serve as a disaster recovery broadcast center for nationwide television coverage.</p> <p>The Office of the President - Presidential Communications Office (OP-PCO) will take the lead in managing and maintaining the facility. Much like the Mindanao Media Hub in Davao City, the VMH will also house field offices of OP-PCO attached agencies/government media such as the People's Television Network, Inc. (PTNI), Bureau of Broadcast Services (BBS), Philippine Information Agency (PIA), Philippine News Agency (PNA), and Radio Television Malacañang (RTVM). Further, there will be allotted offices for the following agencies: (1) Department of Information and Communication Technology, (2) Bureau of Communications Services, (3) National Printing Office, APO Production, Inc., among others.</p>

2. TECHNICAL

2.1 Track Record Certifications

2.1.1 The equipment provider/bidder must have a track record of **Supplying, Delivering, and Testing of Mirrorless and Full-frame Cinema Cameras with Complete Accessories for a minimum of FIVE (5) years.**

2.1.2 The equipment provided/bidder must have a track record of audio/video/computer base broadcast equipment for similar projects of Supply, Delivery, Integration, Installation, Training and Commissioning for a minimum of FIVE (5) years.

2.1.3 The equipment provider/bidder should have an existing or valid certificate of exclusive/distributorship/authorized dealer as proof from the manufacturer.

2.1.4 The equipment provider/bidder must show Purchase orders, Single contracts of similar items procured within the last FIVE (5) years. The previous POs or contracts shall be at least Fifty (50%) of the Approved Budget for the items to be bidden.

2.1.5 The equipment provider/bidder is required to provide/show a proof of confidence on their previous project, product and/or system offered to installed, local or abroad and provide a satisfactory performance certificate from the present clients/end-user/company.

2.1.6 Certification from the principal that the provider/bidder is authorized to transact with PCO and no other gathered information on their past/previous/present project.

2.1.7 Certification from the principal that the equipment provider/bidder has the technical knowledge capability for a 24/7, 365 days a year equipment repair, maintenance and support service.

3. Special Conditions of the Contract

3. 1. Payment Terms: Best Payment Terms in Philippine Pesos delivered to site.

3.2 Scope of Work and Instruction to Bidder

4. Technical Service & Training

4.1 A One (1) week actual training after installation for actual operation and maintenance on site will be held with emphasis on basic adjustments and diagnostics of the equipment.

4.2 The equipment & accessories supplied and delivered should be fully tested at the factory before the shipment. Failed to operate or was subjected for repair during the set-up and installation, integration and training is required for replacement.

4.3 Equipment & accessories supplied failed to operate during operation or were subject to.

repair within the warranty period should be replaced by a temporary service unit by the bidder/integrator.

5. Technical Support & Warranty

5.1 All hardware and software shall have a minimum of one (1) year free replacement warrant with extended one (1) year warranty support service-on-site is included on the proposal.

5.2 The bidder/integrator shall have 24/7 telephone (or) e-mail technical support and shall provide all the service needed to facilitate the communication from local or international technical support teams dividing the warranty period.

5.3 The bidder/integrator shall provide the temporary/compatible replacement service unit for defective equipment, during the warranty period to ensure the integrity of the whole studio audio system project in case some supplied/installed equipment failed to operate or was subjected for repair within the warranty period.

5.4 The bidder/integrator shall ensure the proper actual testing and procedure with hard copy template as guide for studio audio system from input/output signal source, during actual operation on all audio equipment and accessories for successful commissioning and Acceptance.

5.5 The proposed actual testing/operation procedures shall include all the features and functionality parameters of all audio equipment and accessories, including the individual cable number & name tag, as part of the cable management system.

5.6 The bidder/integrator shall provide the comprehensive on-site training to operate the machine. They are also required to provide their own technical personnel to train the studio production crew in the whole audio system, set-up and operation

5.7 During warranty period, the bidder/integrator shall provide the necessary preventive maintenance, support/service, calibration/adjustment, repair/rectification of problems encountered and software updates free of charge

5.8 The bidder/integrator must submit the detailed technical specifications of studio audio system design based on the conceptual view provided in the succeeding pages

NOTE: The above-mentioned eligibility requirements are in addition to the eligibility requirements under R.A. 9184.

2.2. The source of funding is the **2023 General Appropriations Act**.

3. Bidding Requirements

The Bidding for the Project shall be governed by all the provisions of RA No. 9184 and its 2016 revised IRR, including its Generic Procurement Manuals and associated policies, rules and regulations as the primary source thereof, while the herein clauses shall serve as the secondary source thereof.

Any amendments made to the IRR and other GPPB issuances shall be applicable only to the ongoing posting, advertisement, or **IB** by the BAC through the issuance of a supplemental or bid bulletin.
