Clarifications of the following items:


- 1. Item No. 1.0, can we offer lower than 95% but not lower to 90% CRI & TLCI on all fixtures?
- 2. Item No. 1.0. Whether we can offer panel surface area with different sizes because every manufacturer has different sizes of lighting fixtures?
- 3. Item No. 2.0. Whether we can we offer Color Temp from 2700k-10000k?
- 4. Item No. 1 to No. 5 Whether all Pole Operated, meaning you can focus the lighting fixtures standing on the floor without climbing to a ladder to focus the lights?
- 5. Item Nos. 3.0, 4.0 & 5.0 Whether could be hanged and adopt a clamp without a problem as we analyzed the DMX data is not built -in, separated to the fixture which is difficult to hanged these fixtures is designed for ground operation not intended for hanging?
- 6. Item No. 14.0 Clarifications on how many KVA of Power Transformer required?

- 1. The CRI for all lighting fixtures must be at least 95%, and the TCLI must be at least 92%.
- 2. The required size, stated in the Technical Specifications, is 25 inches x 12 inches, which is equal to 300 square inches. The bidders may offer a total surface area (LxW) equal to or larger than 300 square inches.
- 3. No, Color Temp from 2700k-10000k is not accepted. A dynamic colour temp 2000K-10000K is required.
- 4. Lighting fixtures must be pole-operated to be installed in the lighting grid battens. This is a standard practice for studio lighting.
- 5. The lighting wiring systems shall be designed carefully by the winning bidder for the intended operation of the studio lighting.
- 6. Approximately 100KVA is recommended. However, the winning bidder should calculate the transformer's practical power based on the total supply of their supplied


