- IV. The supplier is required to complete the setup 6 to 24 hours prior to the event and proceed with dismantling after the event concludes.
- V. The final design and specifications will be provided by PCO-DMS.
- VI. The supplier must deliver the services/goods on or before the specified delivery dates to avoid incurring liquidated damages for late delivery.
- VII. Final or additional requirements and instructions will be communicated by the representative of PCO-DMS.


