Payment Terms: Payment shall be made upon completion of service/s and submission of required payment documents in accordance with the existing government accounting rules and regulations.

Liquidated Damages: Liquidated damages equivalent to onetenth of one percent (0.01%) of the cost of the unperformed/undelivered portion for every day of delay shall be imposed.

The PCO may rescind the contract once the cumulative number of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.

- I. The meals/beverages served must be of high quality and prepared in a clean and hygienic manner in accordance with all health and safety regulations;
- II. The winning Supplier or Service Provider shall also prevent meals cooked that are easily spoiled. Any spoiled food will be subject for penalties and subject for blacklisting:
- III. Supplier shall quote the lowest price on the item/s listed and submit a filled-out quotation duly signed by their representative;
- IV. Supplier must be **PhilGEPS Accredited (at least Red Membership registration)**;
