Booking dates may be changed/rebooked , within one (1) month, upon notification at least three (3) days before the scheduled event date originally booked.		
Prospective bidders shall prevent meals that are easily spoiled. Any spoiled food will be subject to liquidated damages and any appropriate penalties including blacklisting in the PCO .		
In cases of unforeseen contingencies (i.e., Force majeure) the enforcement, postponement, and termination of the contract will be upon the recommendation of the PCO .		
Payment Terms: Payment shall be made upon completion of service/s and submission of required payment documents in accordance with the existing government accounting rules and regulations;		
Liquidated Damages: Liquidated damages equivalent to one-tenth of one percent (0.01%) of the cost of the unperformed/undelivered portion for every day of delay shall be imposed;		
The PCO may ex-parte rescind the contract once the cumulative number of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.
