Whether a supplier is allowed to submit an aggregated contract instead of a Single Largest Completed Contract Approved Budget for the Contract (ABC)?	The EU affirmed to accept aggregated contracts maximum of two (2) contracts that equal to fifty (50) percent of the Approved Budget for the Contract.
What is the timeline for the contract validity under SLCC?	The contracts submitted for SLCC must have been completed within three [3] years prior to the deadline for the submission and receipt of bids.
