I. Section II. Instructions to Bidders

CLARIFICATION/S	ANSWER/S
A supplier asked for clarification on SLCC.	<p>As stated on the Bidding Documents, <i>Section II. Instruction to Bidders; 5.3 Eligible Bidders:</i></p> <p><i>“Pursuant to Section 23.4.1.3 of the 2016 revised IRR of RA No.9184, the Bidder shall have an SLCC that is at least one (1) contract similar to the Project the value of which, adjusted to current prices using the PSA’s CPI, must be at least equivalent to:</i></p> <ol style="list-style-type: none"> <i>I. Completed at least two (2) similar contracts, the aggregate amount of which should be equivalent to at least twenty-five percent (25%) of the ABC for this Project; and</i> <i>II. The largest of these similar contracts must be equivalent to at least half of the percentage of the ABC as required above.”</i>
A supplier asked if it is possible to submit the previous company’s ITR, Mayor’s Permit, PhilGEPS Certificate and other required documents because of the company’s transition period.	It is not permitted to submit the old required documents to be able to join the project. The supplier should submit the newly registered documents under the name of the present company.
