- **II.** Supplier shall submit a signed proposal/quotation and submit details of your company.
- **III.** The winning Supplier or Service provider will submit all necessary permits issued by various government agencies (e.g., sanitary and operational permits)
- IV. In case of spoilage, the caterer shall be obliged to: Replace the spoiled food **immediately**, or the total cost of the spoiled food will be deducted from the total contract price, or **Outright cancellation** upon reaching **ten (10) percent** of the total amount of the contract price.
- **V.** In case of **food poisoning**, there shall be an outright cancellation of the contract. The caterer may be held liable for blacklisting. The caterer shall shoulder the expenses in the case of hospitalization/medical treatment of personnel and/or guests affected.
- **VI.** The total cost of the spoiled food will be deducted from the total contract price, or
- **VII.** Supplier shall quote the lowest price on the item/s listed and submit a filled-out quotation duly signed by their representative;
- VIII. Supplier must be PhilGEPS Accredited (at least Red Membership registration);

- **X.** Payment will be on a **SEND BILL ARRANGEMENT**, i.e., full payment will be made after the completion of the event of delivery of the service/product;
- **XI.** The price quotation shall be **inclusive of all costs** and applicable taxes (i.e., VAT, delivery fee, bank, and other charges);

- 6. Any interlineations, erasures or overwriting shall be valid only if they are signed or initiated by you or any of your duly authorized representative/s.

- 8. The PCO shall have the right to inspect and/or to test the goods to confirm their conformity to the technical specifications.
- 9. Payment shall be made after delivery and upon the submission of the required supporting documents, i.e., Order Slip and/or Billing statement, by the supplier, contractor or consultant. Our
