

## Section VII. Technical Specifications

Bidders must state “**Comply**” in the column “**Statement of Compliance**” against each of the individual parameters of each “Specifications.”

*‘Bidders must state here either “Comply” or “Not Comply” against each of the individual parameters of each Specification stating the corresponding performance parameter of the equipment offered. Statements of “Comply” or “Not Comply” must be supported by evidence in a Bidders Bid and cross-referenced to that evidence. Evidence shall be in the form of manufacturer’s un-amended sales literature, unconditional statements of specification and compliance issued by the manufacturer, samples, independent test data etc., as appropriate. A statement that is not supported by evidence or is subsequently found to be contradicted by the evidence presented will render the Bid under evaluation liable for rejection. A statement either in the Bidders statement of compliance or the supporting evidence that is found to be false either during Bid evaluation, post-qualification or the execution of the Contract may be regarded as fraudulent and render the Bidder or supplier liable for prosecution subject to the provisions of ITB Clause 3.1(a)(ii) and/or GCC Clause 2.1(a)(ii).’*

1 Lot	<b>Bandwidth Requirements:</b> 500 Mbps Internet access, Committed Information Rate (CIR) full bandwidth direct internet via Fiber Optic Cable facility to be installed at the New Executive Building, Gate 3, J.P. Laurel St., Malacañang.	
	Must include one (1) Modem (Generic).	
	At least five (5) usable Public IP addresses.	
	<b>Mandatory Requirements:</b> Minimum of five (5) year experience in Internet service network platform.	
	Must provide web access to usage, network performance statistics and web-based traffic utilization (MRTG).	
	Must demonstrate that it has a minimum of 99.6% Service Level Agreement on all data service contracts.	
	At least 99.5% uptime on all facilities and internet connection included in the contract & network at any point in time/daily.	
	Guaranteed response time of 15 minutes from receipt of notice of the fault. And submission of incident report within 24 hours from resolution of faults encountered.	
	Must be able to attain connectivity latency of at least 20 milliseconds to verify, testing of latency. It will be done by conducting a ping test from a single workstation to the router.	
	Certificate of Testing shall be provided upon completion of the project.	
	There shall be no data usage limit. Bandwidth throttling shall be deemed a breach of contract.	

	Contract duration: One (1) Year contract.	
	Conduct of ocular inspection prior to submission of bid and submission of Ocular inspection certificate.	
	Payment Terms: Send Bill Arrangement (Monthly billing).	
	The current (primary) Internet Service Provider (ISP) of the Presidential Communications Office (PCO) shall be disqualified from participating in the public bidding for the procurement of Internet bandwidth backup of 500 Mbps.	
	<b>Delivery Schedule:</b> Within thirty (30) calendar days upon issuance of Notice to Proceed (NTP).	
	<b>Terms of Payment:</b> <ul style="list-style-type: none"> <li>a. Payment terms is in a Send Bill Arrangement (Monthly); and</li> <li>b. Payment shall be subject to applicable taxes, auditing, and accounting rules and regulations and existing rules and regulations of PCO relative to payment of procurement contracts.</li> </ul>	
	<b>Penalty for Delay:</b> When the winning bidder fails to satisfactorily deliver goods under the contract within the specified delivery schedule, inclusive of duly granted time extensions, if any, the supplier shall be liable for damages for the delay and shall pay PCO liquidated damages, not by way of penalty, an amount equal to one-tenth (1/10) of one percent (1%) of the cost of the delayed goods scheduled for delivery for every day of delay until such goods are finally delivered and accepted by PCO.
