Sequence of Sampling approval and Delivery:

- Upon the issuance of the **Notice of Award (NOA)** and **Purchase Order (PO)**, the successful bidder must provide a sample of the customized polo shirts and jackets. These samples should feature the **actual PCO and Bagong Pilipinas** logos, along with the specified texts and meet all outlined specifications. The samples, including size variations for the jackets, must be delivered to the End-user unit **within FIVE (5) calendar days from the issuance of the NOA and PO.**
- The End-user unit is required to communicate the precise sizing for the jackets to the winning bidder within 3 calendar days. The quantities for each size will be determined during the fitting of the sample.
- If the completed sample requires any changes, the winning bidder must submit the **proposed revisions within 3 working days.**
- Once the finished sample delivered by the winning bidder is approved by the End-user unit and the exact sizing of the jackets has been endorsed,

the winning bidder will have 15 calendar days to produce and deliver the polo shirts and jackets, starting the day after the approval.
